# Woolworths Limited and Country Women's Association Community Grants Guidelines

The grants provide local funding to community organisations in rural and regional Australia.

The Woolworths and Country Women's Association Community Recovery Grants program provides the opportunity for community organisations to receive up to \$3,000 in funding for initiatives that strengthen community and social infrastructure, and have a long term benefit to the community in areas affected by drought/dryness.

### ELIGIBILITY

### Who is eligible?

- Community groups e.g. seniors groups, community halls, drama clubs, Lions Clubs, Rotary etc.
- not-for-profit community organisations and charities
- Sporting groups

#### Who isn't eligible?

Individuals, schools and for-profit organisations are not eligible to apply for funds through the grants program

### The following activities will be eligible for funding:

- Upgrades to community social infrastructure
- Equipment for upgrades of sporting clubs and volunteer services

#### The following activities are not eligible for funding:

- Individuals looking for support or raising money
- School or community fetes, community barbecues or one off events
- Religious organisations for religious activities
- Political organisations or charities with political policies.

#### **GRANTS CRITERIA**

- 1. Name of town, population size (Grants offered to rural towns/communities with a population of 20,000 or less)
- 2. Please advise if town/area is EC declared or has exited from EC declaration in the last 12 months
- 3. What is the primary role of your organisation?
- 4. Brief description of project that requires funding
- 5. Why is the project needed?
- 6. Who would be involved in the community with the project? e.g. number of volunteers
- 7. What other funding/community contributions are being made to the project?
- 8. Estimated completion date
- 9. Other funding/assistance already received or applied for?

**NOTE**: All groups who receive a grant must provide the CWA with a report to confirm the project has been completed. Please include photos, community feedback etc.

# ASSESSMENT OF GRANT APPLICATION

If possible applications will be initially reviewed and endorsed by a local CWA branch. All applications are then forwarded to the State CWA for processing, based on the selection criteria.

The grants program gives preference to proposals that:

- Demonstrate skills and commitment to accomplish the proposed work
- Have towns and communities that have been E.C declared or have recently exited from declaration
- Fulfil the objectives of the grants program
- Have a detailed project budget
- Contribute to the community needs and social infrastructure
- Demonstrate that the economic conditions generated by dryness have created a deficit in investment (in both capital and human resources)
