What does this drought funding package include?

Increased financial support - \$279 million in NSW Budget 2018, bringing NSW Government's drought relief package to more than \$579 million (over half a billion dollars).

- Farm innovation fund additional \$250 million.
 - \$250,000 low interest loans to improve infrastructure and ensure long term productivity and sustainable land use
 - \$50,000 seven-year interest free loan for fodder and grain and to install water infrastructure
 - o Funding to collect and store genetics of their herd or flock
- Streamlining kangaroo management to reduce kangaroo numbers
- Doppler weather stations three new Doppler radar weather stations in the Central West and Far West of NSW to provide real time weather coverage for 30% of the state.
- Funding for mental health \$4 million. Support for 13 state-wide coordinators through the Centre for Rural and Remote Mental Health and counselling support through the National Association for Loss and Grief.

Will I be eligible for funding?

I'm not coping.

Drought can be an exceptionally stressful time. I suggest you speak with a counsellor from the Rural Aversity Mental Health Program. They are specially trained to provide help to people living in rural communities. In an emergency you need to call 000 or go to your nearest hospital Emergency Department.

Why aren't LLS rates being waived?

Local Land Services rates are critical to fighting biosecurity risks and outbreaks, such as yellow crazy ants at present, disease surveillance and managing travelling stock reserves, which are essential during drought. Longer term payment plans are available for those landholders who may have trouble paying their rates.

How do I connect with commercial kangaroo harvesters?

The process is still being negotiated between Department of Primary Industries and the Office of Environment and Heritage. Keep an eye on the droughthub website for more information as it becomes available.
