Why cross-property planning?

In 2009, groups of landholders at Kyeamba Valley and Humula came together to develop cross-property conservation plans. The goal was landscape scale change, recognising that the enviroment doesn't finish at property boundaries.



Responding to the production essentials and knowledge needs in each area, a series of workshops are on offer drawing on expertise from a range of partners including NSW DPI and the Conservation Management Network. These can include paddock plants ID, flora & fauna audits, rotational grazing, connectivity, farm dam management, native grasses.

Implementing management plans

The cross-property groups will recommend actions on each property to achieve landscape scale conservation goals. Direct funding is available through each group to support key actions such as

- * weed control
- * fencing
- * revegetation
- * stock water management
- * biodiversity audits & monitoring

What's in it for me?

- * An opportunity to work alongside others from your community to share ideas, see other management strategies in action, to build community knowledge and expertise
- An opportunity to discuss alternative management options for your property with scientists, agency experts and other producers.
- * An opportunity to learn more about the native vegetation and wildlife in your area and how can assist in protecting them
- An opportunity to access support and funding to carry out work on your property to improve your production/conservation balance and to assist with increasing landscape connectivity.

Rights & responsibilities

This project will deliver support and funds through the cross-property planning groups. No legal contracts are required with individual property owners. Each group will make decisions about works across the properties which contribute to a healthier balance between production and conservation.

Property owners will committ to their group and to Murrumbidgee Landcare that works on their property will be monitored and protected for a minimum of 10 years.
